The annual fee for Texas includes \$25.00 collected by New Direction Trust Company. The annual fee for Delaware and Canada includes a \$25.00 or 2 basis points (whichever is higher) fee collected by New Direction Trust Company. Storage fees are billed annually. Depository storage fees may be paid from the cash balance in an IRA, provided that there are sufficient undirected funds in the account. An account holder may choose instead to pay depository storage fees via credit card or check made payable to New Direction Trust Company.

## 4. DISCLAIMER FOR INTERNATIONAL STORAGE



### **WITHDRAW YOUR CONSENT WITH NDTCO**
