**GARNISHEE CALCULATION SHEET FOR EARNINGS**

1. The employer's current payday is 9-10-19. The principal defendant's gross earnings from the employer that were earned for this pay period are: \$ 416.00
2. Deductions required by law to be withheld from gross earnings shown on line 1:
- a. Federal withholding tax (for income tax) \$ 18.91
  - b. State withholding tax (for income tax) \$ 17.68
  - c. Employee portion of social security tax \$ 25.79
  - d. Employee portion of medicare tax \$ 6.03
  - e. City withholding tax (for income tax) \$ 4.16
