GARNISHEE CALCULATION SHEET FOR EARNINGS

1. The employer's current payday is 9-17-19. The principal defendant's gross earnings from the employer that were earned for this pay period are: \$ 497.90
2. Deductions required by law to be withheld from gross earnings shown on line 1:
- a. Federal withholding tax (for income tax) \$ 27.10
 - b. State withholding tax (for income tax) \$ 21.16
 - c. Employee portion of social security tax \$ 30.87
 - d. Employee portion of medicare tax \$ 7.22
