**GARNISHEE CALCULATION SHEET FOR EARNINGS**

1. The employer's current payday is 9-24-19. The principal defendant's gross earnings from the employer that were earned for this pay period are: \$ 520.00
2. Deductions required by law to be withheld from gross earnings shown on line 1:
- a. Federal withholding tax (for income tax) \$ 29.31
  - b. State withholding tax (for income tax) \$ 22.10
  - c. Employee portion of social security tax \$ 32.24
  - d. Employee portion of medicare tax \$ 7.54
  - e. City withholding tax (for income tax) \$ 5.20

  - g. Total (add lines 2a through 2f) \$ 96.39
3. **Disposable earnings** (subtract line 2g from line 1) \$ 423.61
