2009 two story colonial. House does not have water management (gutters) or kick out flashing.

Streamline onsite for damaged sheeting on back right corner under deck.

Upon inspection damage uncovered to sheeting behind siding in several areas

*Back right, back inside corner of garage, front entrance.

-Six kick-out flash installed to direct water out of corners creating issues

-Four 12' 5 1/4 x 12' deck boards, add correct z-bend metal flashing

-Remove and reinstall up to three square of clay 4 over 4 siding sections

-Up to eight (8) sheets OSB 4x8 installed

-Cedar trim around front entrance up to 60' 1x4 & 1x6 installed unpainted


