Abstract. The aim of this study was to evaluate the effect of the addition of Ca^{2+} to the resin-modified glass ionomer cements (RMGICs) on the mechanical properties and the water sorption. The RMGICs were prepared with the addition of 0, 10, 20, 30 and 40% Ca^{2+} to the resin-modified glass ionomer cements (RGMICs).

The mechanical properties of the RMGICs were evaluated by the three-point bending test and the water sorption was evaluated by the water sorption test. The results showed that the mechanical properties of the RMGICs were increased with the addition of Ca^{2+} and the water sorption was decreased with the addition of Ca^{2+} .
