**Workers' Compensation** - Please revise to read as follows:

"Each employer shall notify his or her employees of the ombudsman's service in a manner prescribed by the Director of the Department of Industrial Relations. The notice shall include the posting of a notice in one or more conspicuous places."

**Child Labor** - The flyer language is correct as is.

**Unemployment Insurance** - Please revise to read as follows:

"Every employer . . . shall post and maintain printed notices to his workers informing them that he is liable for contributions under the Alabama Unemployment Compensation Law and has been so registered by the Director. Such notices . . . shall be posted and maintained in conspicuous places near the actual location where the workers' services are performed."
