Failure to respond to this complaint will result in a final case disposition of "Closed No Response" and the matter could be forwarded to the Department's Investigation Section to perform a compliance audit and possibly initiate administrative action against your business. Please be aware that case disposition is a matter of public record and will be provided to consumers, news agencies, other state agencies, and any other interested parties.

We are writing this complaint due to the fact that in April 2018 we received ~~an~~ an Annual Report form to be paid to have a business in Florida - We sent the funds via check - Come to find out in March 2019 that our business was dissolved due to not completing our annual report. Although we paid \$150.00 April 2018 and \$150.00 March 2019.

--What would satisfy your complaint?

We had to pay \$600.00 to reinstate our business in Florida, unaware that we were not doing what was required of us for year 2018 and 2019 - 150 each year = 300 plus \$600.00 to re-instate company.

--The department cannot require businesses to take a particular action such as repairing or replacing a product, or refunding money. The department may act as a mediator to attempt dispute resolutions; however, on occasion, the only recourse is to seek legal remedy through the court system.

My signature authorizes the Department of Agriculture and Consumer Services to take any action deemed necessary for purposes of mediation, investigation or enforcement. I understand that the department does not give legal advice, and cannot take legal action for me. I am filing this complaint to notify the department of the activities of this business/ individual and to seek any assistance available. 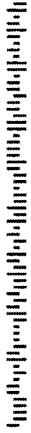
