Interest and fees on the amount due

- Interest is charged at a rate of 18% on overdue (delinquent) Wisconsin Department of Revenue (DOR) debt. The interest rate for debt referred from other agencies is based on their laws.
- We will charge you a collection fee on DOR tax debt equal to 6½% of your amount due, with a minimum charge of \$35.00. The collection fee for state debt referred by another agency is 15% of the amount due, with a minimum charge of \$35.00.

Collection information

If you don't pay

This debt will be subject to collection actions, including wage attachment, levies, and filing of tax warrants

A tax warrant

- Places a lien against your property
- Is a public record
- Your credit rating may be impacted
- There is a \$10 fee for tax warrants
- If you have a payment plan, a tax warrant may still be filed

Refund and payments

We will apply the following to your debt:

- Your state tax refunds
- Other payments given to you, including Federal refunds and vendor payments, state vendor payments, refunds from other states, lottery prize winnings, and unclaimed property

Internet posting

- If you owe more than \$5,000 of DOR tax debt, we are required by law to post your name on the Internet
- An approved payment plan stops Internet posting

***EST means Estimate Liability**– If a 'Y' is in the EST column, we estimated the amount of tax due. You need to either file a return or provide information to show you were not required to file a return for this period. Payments made on estimated liabilities may not be refundable.

- Sales and Use tax returns must be filed within two years of the estimated date.
- Withholding tax returns must be filed within four years of the estimated date.

Appeal Rights- If the billing status says 'appealable' you can file your appeal within 60 days of the original Notice of Amount Due. Clearly explain why you don't agree with the notice. Attach or include any documents to support your appeal. If appealing by mail, type or neatly print and sign your appeal and write your tax account number and tax period from the original Notice of Amount Due on all documents you include with your appeal.

- For business taxes in *My Tax Account*:
 - Go to tap.revenue.wi.gov
 - Log in to *My Tax Account*
 - Select the tax account
 - Select "Appeal Request"
- For individuals, fiduciaries and business taxes not in *My Tax Account*:
 - Go to tap.revenue.wi.gov/services
 - Select "Appeal a bill/notice"
