



Thank you for booking with uShip! Here are some quick tips to help you avoid additional charges and have a smooth shipping experience.

Hand the uShip Bill of Lading (BOL) to the driver at pickup. Failure to use the uShip BOL will result in additional charges and could delay transport.

Prepare Your Shipment

Ensure your shipment is properly packaged with all items secure and protected to avoid possible damage. Your shipment will be cross-docked with a forklift multiple times and should be packaged appropriately.

If you are shipping an engine or other mechanical goods, we recommend enclosing the shipment in a crate.

Document Your Shipment

We recommend that you take pictures of your shipment prior to pickup in case there are damages during transit. If possible, take pictures of your spec sheet or your shipment on a scale to avoid disagreements about weight.

Review info on the uShip Bill of Lading

If your origin location requires any special identification numbers, make sure they are written on the uShip BOL in the Additional Services field.

Add notes on the uShip BOL if a pickup service has been paid for but not rendered. For example, if a liftgate at pickup was paid for but not used, you should note it on the BOL prior to releasing your freight to the driver.

Receiving the Shipment

At delivery, be sure the consignee reads the delivery receipt (DR) before signing. If there were services listed in the DR but not rendered on delivery, add notes on the DR that these services were not performed. Double check the DR and look for additional charges when signing.

Pickup/Delivery Information

Contact the carrier using the information provided below if you have questions about pickup/delivery status, the location of a truck, or your timeframe. Ask for Dispatching, and your carrier will be able to provide the most recent information for expected pickup/delivery. You can use location and address information from Pickup or Delivery to reference your shipment.

Parties agree that uShip will be fully indemnified and held harmless for all fees, expenses and costs incurred by uShip arising from or related to the fault, negligence or misconduct of the parties.
