4. Did your firm send a package of labor law posters to Kim Dennis, manager of Lee's Famous Recipe Fried Chicken, (Customer ID: 85045318, Address: 178 S. Dixie Blvd., Radcliff, Ky.) and include an invoice for \$67.25 she is due to your business for those posters? If so, why?
5. Why are you selling posters that are free from the government?
6. How do you answer to these allegations that your business is involved in a scam?
