Hereditary Hemochromatosis

Result: Mutations Tested: C282Y H63D S65C

Mutations Detected: neg/neg POS/neg neg/neg

Interpretation: Given that the sample we received is from the individual identified above, this person tested positive for one H63D mutation. This is consistent with being a carrier of hereditary hemochromatosis.

These three mutations account for approximately 90% of cases of HFE-associated hereditary hemochromatosis. Therefore, not all individuals with hemochromatosis are identified by genetic testing. The diagnosis of hemochromatosis should be based on clinical criteria.

This persons relatives are also at an increased risk for hereditary hemochromatosis and may wish to consider genetic testing or monitoring of their iron levels. Genetic counseling should be considered and can be scheduled by calling MSU's Genetics Clinic at (517) 364-5440.
