Dues Calculations

A. Basic Membership Dues are \$50.00 each quarter.

B. Percentage Dues are 1.5% of all gross earnings over \$10,000 (including residuals) in a calendar year up to a maximum of \$300,000.

C. Residual Dues are 1% of all Residual Payments.

Employment in a Higher Category

Please note that should you accept employment in a Guild category that requires a higher initiation fee, it will be necessary for you to pay the difference between your current initiation fee and the initiation fee for your new category.

Reported Earnings

Report only income received as gross salary, overtime, vacation pay, severance pay, residuals not already processed by the Guild, deferments, percentage compensation, profit participation, and fees of all kinds in any guild category paid to you or your loanout company. **Please do not itemize Guild-processed residuals.**

Dues that remain unpaid for six months will result in suspension of membership. Since dues cannot be assessed if you have unreported earnings, failure to declare earnings and pay dues in full by the due date will result in a \$25 Bookkeeping Fee. Also, members who do not pay dues within the allotted time will be charged a \$25 Bookkeeping Fee. If a member receives a Bookkeeping Fee notice, something is amiss with that member's account and he or she should contact the DGA Membership Department.

Payments are first applied to the OLDEST outstanding debit on the account. It is important to pay the total amount under AMOUNT DUE to avoid a Bookkeeping Fee.

If the words "**EARNINGS UNREPORTED**" appear on a member's Statement, please call the Membership Department immediately because that member's membership may be in danger of suspension.

DGA-PAC Information

The DGA-PAC supports candidates for federal office who support the interests of all members of the Directors Guild of America, Inc., and who promote a federal legislative and administrative agenda that will benefit the members of the DGA.

Members have the right to refuse to contribute without any reprisal. Only United States citizens and resident Green Card holders are eligible to contribute to the DGA-PAC. The DGA-PAC may not accept contributions drawn on corporate accounts or from LLCs that have elected to be treated as corporations for IRS purposes. (DGA-PAC may accept contribution from partnerships, including LLPs, provided that the contribution is attributed to an individual partner and that DGA-PAC is informed of the attribution to the individual.)

To insure that your dues account is properly credited, please DO NOT indicate an amount on the DGA PAC CONTRIBUTION line unless you intend to donate a non-tax deductible voluntary contribution to the DGA-PAC IN ADDITION TO YOUR DUES PAYMENT.

Contributions to the DGA-PAC are not deductible as charitable contributions for federal income tax purposes. Federal law requires PACs to report the name, address, occupation and employer for each individual contributor aggregating more than \$200 in a calendar year.
