

Konica Minolta / GBC Conditional Sale Agreement

Terms & Conditions

For the trial of KIP C7800 Digital Printer & ACCO GBC 5031 TS Automated Lamination System

The Conditional Sale/Trial will require an approved PO issued to Konica Minolta Business Solutions for the KIP C7800 Digital Printer and the GBC 5031TS Lamination System for Installation, Training and Freight. Additional usage charges for KIP C7800 will also be included as listed in the Final Terms and Conditions on page 2.

ACCO Brands/GBC - is confident our 5031TS two sided automated laminating system will reliably feed, laminate and trim prints run on the KMBS / KIP C7800 printer given the following parameters:

1. C7800 prints will be on 20# media and laminated using GBC 1.5 mil NAP II laminating film.
2. Depending on the direction the 18" X 24" are fed in to the laminator output speed will vary from 24 feet to 300 feet per minute.
3. Depending on the experience level of the operator sheet misfeeds would be acceptable up to 5%. More experienced operator can expect up to 3% misfeeds.
4. The 5031TS system will require operator oversight while running. The system cannot be expected to operate unattended.
5. The 5031TS Laminating system installed for trial will be a demo system and will be the system purchased.

The Conditional Sale Agreement will extend up to 30 days following the installation and training on the 5031TS system after such time the sale will be deemed final.

In the unlikely event the GBC 5031TS system cannot reliably run the within the parameters spelled out above the system may be returned to GBC. No other reason will be justification for return.

Konica Minolta Business Solutions - is confident the KIP C7800 Digital Printer will reliably print and maintain acceptable print quality based on the following conditions.

- 1) The 20 lb. bond used is rated as a premium bond product.
- 2) The quality of printer output will be equal to the Mandatory Poster Agency Inc. sample prints which have been already approved to meet Mandatory Poster Agency Inc. quality requirements.
- 3) The KIP C7800 will jam less than 3% of the time if Konica Minolta Business Solutions approved media's is used.
- 4) Mandatory Poster Agency Inc. must use OEM approved toner at all times.
- 5) The KIP C7800 Digital Printer installed for trial will be a demo printer and will be the printer purchased. As of 4-29-2013 this printer has 1,782 square feet of usage.

In the unlikely event the KIP C7800 Digital Printer cannot reliably run the within the parameters spelled out above the system may be returned to Konica Minolta Business Solutions. No other reason will be justification for return.

If either the KIP C7800 or the GBC 5031 does not perform within stated Terms & Conditions both pieces of equipment may be returned.

Final Terms & Conditions

- 1) At the time of trial signature Konica Minolta Business Solutions will present Mandatory Poster Agency Inc. their invoice which will be due net 30 as of the final day of trial.
- 2) At the time of trial signature Mandatory Poster Agency Inc. will give Konica Minolta Business Solutions a purchase order for \$10,343.00 for delivery, installation and training for all equipment. If both GBC Laminator and C7800 are purchased a credit will be given to Mandatory Poster Agency Inc. for return freight paid in advance in the amount of \$2,724.00. Proposal presented at time of trial signature will reflect that delivery, installation and freight were pre-paid. An equipment usage charge of \$0.03 per square foot will be charged and must be included on purchase order.
- 3) A maximum usage of 50,000 square feet is all that is allowed for trial period.
